**ORDER DIRECTING COMPLAINANT TO SHOW CAUSE
WHY COMPLAINT SHOULD NOT BE DISMISSED**

On January 23, 2025, the Commission issued an order setting a procedural conference in this matter for February 11, 2025, at 2:00 p.m., to be conducted via WebEx telephone and video conference. Counsel for Union Electric Company d/b/a Ameren Missouri and counsel for the Staff of the Commission appeared for the hearing at the scheduled date and time. Complainant Dominic Mikel did not appear.

Per Commission Rule 20 CSR 4240-2.090(5), "Failure to appear at a prehearing conference without previously having secured a continuance shall constitute grounds for dismissal of the party or the party's complaint . . . unless good cause for the failure to appear is shown." The Commission will order Mr. Mikel to file a pleading showing cause as to why his complaint should not be dismissed.

THE COMMISSION ORDERS THAT:

1. Complainant Dominic Mikel shall file a pleading no later than February 25, 2025, showing cause why his complaint against Ameren Missouri should not be dismissed for failure to appear.
2. This order is effective when issued.
