On January 23, 2025, the Commission issued its order approving a stipulation and agreement resolving the issues between the parties in this general rate case. That order directed Liberty Utilities (Missouri Water) LLC d/b/a Liberty to file tariffs in compliance with the Commission’s order.

Liberty filed compliance tariff sheets on January 30, 2025, and substituted those tariff sheets on February 10, 2025. Staff filed a recommendation to approve Liberty’s tariff sheets as substituted on February 11, 2025.

On February 13, 2025, Liberty filed a substitute compliance tariff sheet, PSC MO No. 22, Original Sheet No. T 2.1. Liberty’s filing letter states that it is filing this tariff sheet to implement an additional minor correction. That tariff sheet bears a March 1, 2025 effective date.

The Commission will shorten the time for any objections or comments on Liberty’s substitute compliance tariff sheet

1. Any comments or objections to Liberty’s tariff sheet, PSC MO No. 22, Original Sheet No. T 2.1, must be filed no later than February 18, 2025, at noon.
