ORDER REGARDING REQUEST TO REOPEN AND DIRECTING FILING

Issue Date: February 14, 2025 Effective Date: February 14, 2025

On January 15, 2025, the Commission held a prehearing conference via WebEx. Ryan P. Dooley (Complainant) did not appear for the January 15, 2025 prehearing conference and did not contact the Commission to request a continuance of the conference. On January 16, 2025, the Commission ordered Complainant to file a pleading showing cause as to why his complaint should not be dismissed for failure to appear for the prehearing conference. The order noted that failure by a party to appear at a prehearing conference without securing a continuance constitutes grounds for dismissal of a party's complaint unless good cause for the failure to appear is shown. Complainant was ordered to respond by January 31, 2025. No response was filed at that time.

On February 5, 2025, the Commission dismissed the complaint. The following day, Complainant filed a *Response to Order Directing Complainant to Show Cause* indicating that Complainant was never notified about a court date or hearing and that Complainant's attorney and case manager could not represent Complainant without proper notification. Union Electric Company d/b/a Ameren Missouri filed a response on February 10, 2025,

stating Ameren Missouri had no objection to reopening the docket and scheduling a second procedural conference. Ameren Missouri's response also requested that the Commission order Complainant to provide his list of representatives so they can be notified of the date and time of the procedural conference. No attorney has filed an entry of appearance on behalf of Complainant at the time of this order.

Accordingly, the Commission will reopen this case. The Commission also finds the request for Complainant to provide a list of representatives reasonable and will grant it.

THE COMMISSION ORDERS THAT:

- 1. No later than February 28, 2025, Ryan P. Dooley shall file a list of any representatives he has in this matter.
 - 2. This order shall be effective when issued.
