Dear Judge Dippell:

Pursuant to the rules of the Missouri Public Communications Commission (the "Commission")<sup>1</sup>, Section 214(e)(4) of the Communications Act of 1934, as amended (the "Act"),<sup>2</sup> and the rules of the Federal Communications Commission ("FCC")<sup>3</sup>, Co-Mo Comm, Inc. d/b/a Co-Mo Connect ("Co-Mo Connect" or "Company") submits this letter notice seeking the partial relinquishment of its designation as an Eligible Telecommunications Carrier ("ETC") solely in the census blocks identified in **Attachment A**, effective April 25, 2025. Co-Mo Connect was granted ETC designation in these census blocks in Docket Nos. DA-2025-0054<sup>4</sup> and DA-2021-0196.<sup>5</sup>

On June 28, 2024, Co-Mo Connect filed a Notice of Election of Partial Default of its Rural Digital Opportunity Fund Phase I ("RDOF") Auction obligations with the Federal Communications Commission ("FCC"). Co-Mo Connect explained to the FCC that escalating construction costs that started during the COVID-19 pandemic is the cause for its partial RDOF default. A list of the defaulted census blocks is included as **Attachment A**.

On July 10, 2024, the FCC's Wireline Competition Bureau released a Public Notice acknowledging Co-Mo Connect's partial RDOF default, <sup>8</sup> and making the defaulted census blocks eligible for other broadband funding.

Pursuant to 47 U.S.C. § 214(e)(4) and Section 54.205(a) of the FCC's rules, a state regulatory commission "shall permit an eligible telecommunications carrier to relinquish its designation as such a carrier in any area served by more than one eligible telecommunications carrier." An ETC seeking relinquishment must provide advance notice to the state commission of such relinquishment. The subscribers served by the relinquishing ETC must continue to be served by an ETC. Finally, to the extent additional facilities are required to serve any of the relinquishing ETC's subscribers, sufficient notice must be provided to ensure that the construction of any additional facilities necessary to serve the relinquishing ETC's subscribers can be timely completed. The areas where Co-Mo Connect seeks to relinquish ETC designation are served by other ETCs, including DISH Wireless, L.L.C., TracFone Wireless, Inc., Telrite Corporation, Easy Telephone Service Company, YourTel America, Inc., Global Connection Inc. of America and i-wireless, LLC.

Co-Mo Connect has not built out or launched broadband service in the census blocks where it seeks to relinquish ETC designation and does not have any fiber customers in the proposed ETC relinquished area. Therefore, Co-Mo Connect's partial ETC relinquishment will not adversely affect any Co-Mo Connect subscribers and the subscriber notification requirement is, in this case, not necessary.
