## **APPLICATION FOR EXTENSION OF TIME**

**COMES NOW** The Raytown Water Company ("RWC" or "Company"), and, pursuant to Commission Rule 20 CSR 4240-10.145(7), respectfully requests a 90-day extension of time to file its Annual Report. In this regard, RWC states as follows to the Missouri Public Service Commission ("Commission"):

- 1. RWC is a Missouri general business corporation duly organized and existing under the laws of the State of Missouri with its principal office and place of business located at 10017 E. 63<sup>rd</sup> Street, Raytown, MO 64133. A copy of a Certificate of Good Standing issued by the Missouri Secretary of State was submitted in Case No. WR-2022-0139, and there has been no change to that status.
- 2. RWC has no cases pending before the Commission where RWC's activities are the primary focus of the proceedings. RWC has no pending action or final unsatisfied judgments or decisions against it from any state or federal agency or court within the past three years that involve customer service or rates. RWC has no annual report or assessment fees that are overdue.
- 3. RWC is a "water corporation" and a "public utility" as those terms are defined in Section 386.020, RSMo, and is subject to the jurisdiction and supervision of the Commission as provided by law.
- 4. All correspondence, communications, notices, orders and decisions of the Commission with respect to this matter should be sent to the undersigned counsel.

5. RWC will not be able to complete and file its 2024 Annual Report by the due date (April 15, 2025). This is due to a personnel change in the Company's accountant position. An additional 90 days (to July 14, 2025) should allow the Company sufficient time to complete and file its 2024 Annual Report.

**WHEREFORE**, Raytown Water Company, pursuant to Commission Rule 20 CSR 4240-10.145(7), respectfully requests an order of the Commission granting a 90-day extension of time to file its Annual Report.
