## ORDER GIVING NOTICE, SETTING A TIME TO REQUEST INTERVENTION, AND DIRECTING STAFF TO FILE A RECOMMENDATION

On February 17, 2025, Co-Mo Comm, Inc. d/b/a Co-Mo Connect filed a request to partially relinquish its designation as an eligible telecommunications carrier. Specifically, Co-Mo Connect would relinquish those census blocks awarded to it in File Nos. DA-2021-0196 and DA-2025-0054, which are attached as Attachment A to its request.

The Commission will give notice of Co-Mo Connect's filing, set a time for intervention requests, and will direct the Staff of the Commission (Staff) to file a recommendation.

**THE COMMISSION ORDERS THAT:**

1. The Data Center of the Commission shall send a copy of this order to each eligible telecommunications carrier (ETC) in the state of Missouri.
2. Any proper person wishing to intervene in this matter shall file an application to do so no later than March 7, 2025.
3. Staff shall file its recommendation regarding Co-Mo Connect's filing, or a request for an extension of time, no later than March 18, 2025.

4. Any other party wishing to respond to Co-Mo Connect's filing shall do so no later than March 18, 2025.

5. This order shall be effective when issued.
