## **ORDER APPROVING COMPLIANCE TARIFF**

Issue Date: February 18, 2025

Effective Date: March 1, 2025

On January 30, 2025, Liberty Utilities (Missouri Water) LLC d/b/a Liberty filed tariff sheets which were assigned Tracking Nos. JW-2025-0119 and JS-2025-0120 to comply with the Commission's January 23, 2025, *Order Approving Stipulation and Agreement,* which resolved the outstanding issues between the parties in this general water and wastewater rate case. Those tariff sheets bear an effective date of March 1, 2025.

Liberty substituted both sets of proposed compliance tariff sheets on February 10, 2025, to make minor corrections noted by the Commission's Staff (Staff).

On February 11, 2025, Staff recommended that the Commission approve the tariff sheets. No other responses to the tariff sheets were received. However, Liberty filed a substitute tariff sheet on February 13, 2025, under Tracking No. JW-2025-0119 to make another Correction.

The Commission shortened the time for comments or objections to Liberty's February 13, 2025, substitution, but received none.

Upon reviewing the pleadings and Liberty's proposed tariff sheets, the Commission finds Liberty's proposed tariff sheets comply with the Commission's *Order Approving Stipulation and Agreement* and will approve them. To enable the tariff to become effective

on the date requested by Liberty, the Commission finds it reasonable to make this order effective in less than 30 days.

### THE COMMISSION ORDERS THAT:

1. The proposed tariff sheets filed on January 30, 2025, and assigned Tracking No. JW-2025-0119, as substituted on February 10, 2025, and February 13, 2025 are approved to become effective March 1, 2025.

2. The proposed tariff sheets filed on January 30, 2025, and assigned Tracking No. JS-2025-0120, as substituted on February 10, 2025, are approved to become effective March 1, 2025.

3. This order shall become effective on March 1, 2025.
