NOTICE OF DISMISSAL

Issue Date: February 19, 2025

On September 12, 2024, MRG Utilities, LLC (MRG) filed applications to acquire water and sewer systems in File Nos. WA-2025-0090 and SA-2025-0091. The Commission consolidated those files under File No. WA-2025-0090 on November 22, 2024.

On February 11, 2025, MRG filed a notice of dismissal stating that it will no longer seek to acquire these systems. Commission Rule 20 CSR 4240-2.116(1) states that a party may dismiss a complaint without an order of the Commission before prepared testimony or oral evidence has been offered. The parties have not offered prepared testimony or oral evidence. The Commission, therefore, will take notice of the dismissal and this file shall be closed.

On January 8, 2025, the Commission granted its Staff an extension to file a report. That report is now unnecessary and Staff need not file a recommendation or report.
