ORDER SCHEDULING PROCEDURAL CONFERENCE

On August 27, 2024, Confluence Rivers Utility Operating Company, Inc. (Confluence Rivers) and Missouri-American Water Company (MAWC) jointly filed an application requesting that the Commission approve the sale and purchase between them of nineteen small wastewater systems.

The Office of the Public Counsel (OPC) proposed four conditions. Confluence Rivers, MAWC, and Staff indicated an objection to the first three of OPC's proposed conditions, but did not object to condition four. Subsequently, OPC requested an evidentiary hearing.

The respective counsel for the parties provided three dates and times they were available to attend a procedural conference; thus, the Commission will schedule a procedural conference to discuss a procedural schedule leading to an evidentiary hearing.

THE COMMISSION ORDERS THAT:

1. A procedural conference shall be held on February 21, 2025, beginning at 10:30 a.m. The procedural conference shall be held via WebEx, and the meeting information will be emailed to all counsel.
2. This order is effective when issued.

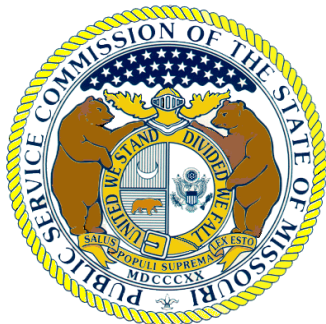
