AMEREN MISSOURI'S NOTICE TO CORRECT THE REBUTTAL TESTIMONY OF ANN BULKLEY

COMES NOW Union Electric Company d/b/a Ameren Missouri ("Company" or "Ameren Missouri") for its Notice to Correct the Rebuttal Testimony and associated schedules of Ann E. Bulkley as follows:

- 1. Since the filing of its rebuttal testimony, it has come to the Company's attention that there are a few inadvertent references to the recommended return on equity and growth rates in the associated schedules and Figure 2 of the rebuttal testimony.
- 2. The following pages correct the reference of 10.20% to 10.25%: page 4, line 16; page 8, line 2; page 11, lines 1 and 6; page 21, line 10; page 60, line 4; page 83, line 15; page 107, line 6; and page 117, line 1. The corrected pages are provided in redline as shown in the attached Exhibit A.
- 3. Additionally, the associated schedules incorrectly referenced the Zach's growth rates for Southern Company and Xcel in Attachment 2, they are highlighted in yellow with red text. When correcting the growth rates, other calculations change, which are also reflected in yellow with red text. The changes to the growth rates effect the individual DCF results from Southern Company and Xcel as well as the Mean and Median DCF results. Attachment 1 summarizes the Mean and Median from Attachment 2, and the resulting correction is also denoted in yellow highlights and red text. The Attachment 1 summary is referenced in the Rebuttal

Testimony in Figure 2 on page 10, and as a result, Figure 2 was also updated to change the Mean and the Medium from the DCF results.

4. Accordingly, Ameren Missouri is submitting, along with this notice, the corrected rebuttal testimony and associated schedules of Ann E. Bulkley to correct the inadvertent references.

WHEREFORE, the Company respectfully requests permission to file the Corrected Rebuttal Testimony of Ann E. Bulkley.
