ORDER GRANTING REQUEST FOR EXTENSION OF TIME

On October 18, 2024, Union Electric Company d/b/a Ameren Missouri filed the above-referenced application. Ameren Missouri wishes to own, operate, maintain, and otherwise control and manage a new substation, and to reconfigure an existing transmission substation, in Cooper County, Missouri. The Commission ordered its Staff to file a Report or Recommendation no later than February 24, 2025.

On February 12, 2025, Ameren Missouri filed an amended application. On February 21, 2025, Staff filed a Request for Extension of time to File Staff Report or Recommendation.

Staff states that Ameren Missouri’s amended application includes a cost estimate nearly double of that included in the original application. Thus, Staff needs more time to investigate this estimated cost increase, and it cannot file its Report or Recommendation on February 24, 2025. Staff asks the Commission to extend the deadline for Staff’s Report or Recommendation to March 20, 2025. Staff represents that Ameren Missouri consents to this request.

The Commission finds the request reasonable, and will grant it.

THE COMMISSION ORDERS THAT:

1. The Request for Extension of Time is granted.
2. The Staff of the Commission shall file a Report or Recommendation no later than March 20, 2025.
3. This order shall be effective when issued.
