ORDER GIVING NOTICE, SETTING A TIME TO REQUEST INTERVENTION, AND DIRECTING STAFF TO FILE A RECOMMENDATION

On February 21, 2025, yondoo Broadband, LLC (yondoo) filed a request to relinquish its designation as an eligible telecommunications carrier (ETC). yondoo was designated an eligible telecommunications carrier in File No. DA-2021-0258. yondoo's requested date to relinquish its ETC designation is April 30, 2025.

yondoo also notified the Commission that the company no longer wished to be registered to provide Interconnected Voice over Internet Protocol (IVoIP) service in the State of Missouri. The Commission granted yondoo IVoIP registration in File No. DA-2021-0256. yondoo's requested date to cancel its IVoIP registration is April 30, 2025.

The Commission has the authority to cancel an IVoIP registration pursuant to Section 392.410.5, RSMo (2016), which states, in part, "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing.¹ Therefore, if no request for a hearing or objection to yondoo's request to cancel its iVoIP registration is received, the Commission may cancel the registration based on yondoo's request.

The Commission will give notice of yondoo's filing, set a time for intervention requests, and will direct the Staff of the Commission (Staff) to file a recommendation.

THE COMMISSION ORDERS THAT:

1. The Data Center of the Commission shall send a copy of this order to each eligible telecommunications carrier (ETC) in the State of Missouri.
2. Any proper person wishing to intervene in this matter shall file an application to do so no later than March 11, 2025.
3. Staff shall file its recommendation regarding yondoo's filing, or a request for an extension of time, no later than March 25, 2025.
4. Any other party wishing to respond to yondoo's filing shall do so no later than March 25, 2025.
5. This order shall be effective when issued.
