On February 21, 2025, Confluence Rivers Utility Operating Company, Inc. (Confluence Rivers) filed tariff sheets pursuant to the Commission’s *Order Approving Acquisition of Assets and Granting a Certificate of Convenience and Necessity*. Those tariff sheets bear an effective date of March 23, 2025. The Commission will direct its Staff to analyze the tariff sheets and file a recommendation. The Commission will also set a deadline for any other responses to Confluence Rivers’ tariff sheets.

THE COMMISSION ORDERS THAT:

1. Staff must file a recommendation about Confluence Rivers’ tariff sheets no later than March 6, 2025.
2. Any other responses to Confluence Rivers’ tariff sheets must be filed no later than March 6, 2025.
