Other parties may also file testimony regarding Empires hedging practices.

COMMISSIONER RUPP ORDERS THAT:

1. The Empire District Electric Company shall supplement its direct testimony to provide a comparison of its present and past hedging practices no later than February 4, 2020, including a copy of its third-party reviewer's report.

2. The Commission's Staff and the Office of the Public Counsel shall file rebuttal testimony comparing Empire's current and past hedging practices no later than March 3, 2020.

3. Any other party may file rebuttal testimony comparing Empire's current and past hedging practices no later than March 3, 2020.
