ORDER CANCELING PREHEARING CONFERENCE

The Commission has scheduled a prehearing conference to occur on January 29, 2020, regarding Unice Harris's complaint against Kansas City Power & Light Company.¹ On the morning of January 29, 2020, Ms. Harris communicated via a voice mail for the presiding officer her request that the prehearing conference be postponed to allow her attorney to enter an appearance.

The Commission has considered Ms. Harris' request, and finds it reasonable and will grant it. The Commission will cancel the January 29, 2020, prehearing conference.

The Commission will reschedule the prehearing conference in a separate order.

¹ Respondent notes that while the claim was filed against Kansas City Power & Light, Ms. Harris was actually a customer of KCP&L Greater Missouri Operations Company, which has undergone a name change to Evergy Missouri West.
