## ORDER RE-SETTING PREHEARING CONFERENCE

On September 18, 2019, Unice Harris filed a complaint against Kansas City Power & Light Company.<sup>1</sup> The Commission scheduled a prehearing conference to occur at noon on January 29, 2020. On the morning of January 29, Ms. Harris requested postponement of the prehearing conference to allow an entry of appearance by her attorney. The Commission granted that request.

The Commission will now reschedule the prehearing conference. For their convenience, the parties may appear by telephone as set out below.

### THE COMMISSION ORDERS THAT:

1. The parties shall appear at a prehearing conference to be held on February 11, 2020, at 10:00 a.m. Failure to appear at the conference without being

excused may result in dismissal of the complaint in accordance with Commission rule 20 CSR 4240-2.090(5).

2. The prehearing conference will convene in Room 305 of the Governor Office Building, 200 Madison Street, Jefferson City, Missouri 65102. The building meets accessibility standards required by the Americans with Disabilities Act. Any person who needs an accommodation to participate in the conference or hearing shall contact the Commission, not later than the day before the conference.
