ORDER SETTING EVIDENTIARY HEARING

On December 27, 2019, the Commission issued its Procedural Schedule order setting this matter for an evidentiary hearing on January 24, 2020,¹ in Jefferson City, Missouri. On January 23, the Commission continued the evidentiary hearing from its January 24 setting because of weather and issued notice that the case would be reset for hearing in Mound City, Missouri, or another place agreed to by the parties because, based on filings subsequent to the complaint, it had become apparent the amount in dispute is less than \$3,000.00 and because Ms. Stinnett resides in Mound City. On January 23, the Commission also ordered the parties to suggest a new date for an evidentiary hearing. On January 28, the parties filed Proposed Hearing Dates, stating they had agreed that the hearing could be conducted in St. Joseph, Missouri, and suggesting it occur on

February 10 or February 13, commencing at 11 a.m. The Commission will set the case for an evidentiary hearing.

THE COMMISSION ORDERS THAT:

1. An evidentiary hearing in this case shall occur on February 13, 2020, commencing at 11:00 a.m. in St. Joseph, Missouri.
2. The Commission will issue further orders identifying the specific location of the hearing.
3. Except as otherwise stated in this order, the Commission's previous order of December 27, 2019, and notice of January 22, 2020, shall remain in full force and effect.
4. This order shall be effective when issued.
