ORDER SUSPENDING TARIFF

On January 3, 2020, Union Electric Company, d/b/a Ameren Missouri (Ameren Missouri), filed an application seeking variance from certain provisions of Commission rule 20 CSR 4240-20.065, concerning net metering applications. Ameren Missouri also submitted a revised tariff sheet with an effective date of February 2, 2020. After the Commission issued a *Notice of Deficiency*, Ameren Missouri, on January 13, 2020, filed a corrected request for variance with a request for waiver of the 60-day notice requirement under 20 CSR 4240-4.017.

On January 16, 2020, the Commission directed notice of the application be provided to media and the General Assembly and allowed until February 14, 2020, for interested parties to intervene.

Because the proposed effective date does not allow the Commission sufficient time to provide notice, allow for intervention and seek the recommendation of the Staff of the Missouri Public Service Commission, the Commission will suspend the tariff sheet.

THE COMMISSION ORDERS THAT:

1. The following tariff sheet filed in this matter by Union Electric Company, d/b/a Ameren Missouri, and assigned Tariff No. YE-2020-0111, is suspended until March 31, 2020, unless otherwise ordered by the Commission:
