**ORDER EXTENDING DEADLINE FOR
STAFF REPORT**

On December 20, 2019, Linda Beecham (Complainant) filed a complaint with the Commission against Missouri-American Water Company (Company). On that date, the Commission ordered the Company to satisfy or respond to the complaint no later than January 22, 2020,¹ and ordered Staff to file a report on the complaint no later than February 6. The Company filed an Answer to the Complaint on January 22, and the Staff filed a Motion for Extension of Time to File Report on January 31. Staff’s Motion states Staff needs more time to file its report because it has pending data requests out to the Company. Staff states some of the data requests concern defenses raised in the Company’s January 22 answer and that the data request responses are not due until February 20. Staff asks the Commission to extend the report deadline to March 6 and states the Company does not oppose the request. The Commission will extend the deadline for Staff’s report.

¹ Unless otherwise indicated, all date references hereinafter shall be to 2020.

1. Staff's Motion for Extension of Time to File Report is sustained.
2. Staff shall file its report on the complaint no later than March 6, 2020.


