ORDER DIRECTING STAFF TO FILE RECOMMENDATION

On January 3, 2020, Union Electric Company, d/b/a Ameren Missouri filed an application seeking variance from certain provisions of Commission rule 20 CSR 4240-20.065, concerning net metering applications. Ameren Missouri also submitted a revised tariff sheet with an effective date of February 2, 2020. After the Commission issued a *Notice of Deficiency*, Ameren Missouri on January 13, 2020, filed an amended request for variance with a request for waiver of the 60-day notice requirement under 20 CSR 4240-4.017.

On January 31, 2020, the Commission issued an order suspending the tariff sheet filed in this matter until March 31, 2020.

The Commission will direct the Staff of the Missouri Public Service Commission to file a recommendation with regard to the application for variance. If Staff finds it requires more time to prepare a recommendation, it may request additional time.

THE COMMISSION ORDERS THAT:

1. No later than February 18, 2020, the Staff of the Missouri Public Service Commission shall file a recommendation regarding the request for variance filed in this matter by Union Electric Company, d/b/a Ameren Missouri.

2. This order shall be effective when issued.
