**ORDER DIRECTING FILING IN RESPONSE TO MEDIATION REQUEST**

Issue Date: February 6, 2020 Effective Date: February 6, 2020

On January 16, 2020, Claude Scott filed a complaint with the Commission against Spire Missouri, Inc., d/b/a Spire. On January 17, 2020, the Commission issued an *Order Giving Notice of Contested Case and Directing Answer*.

On February 3, 2020, Spire filed a *Request for Mediation*, requesting the Commission initiate mediation of this matter and suspend the schedule established in the Commission’s order. The Commission will establish a deadline for Claude Scott to file any response to Spire’s request for mediation. The Commission will also suspend the filing deadline for Spire’s response in this matter to accommodate consideration of Spire’s mediation request.

**THE COMMISSION ORDERS THAT:**

1. Claude Scott shall file any response to Spire Missouri, Inc. d/b/a Spire’s request for mediation and request to suspend the case schedule no later than February 18, 2020.

2. Spire Missouri, Inc., d/b/a Spire's obligation to file a response to Claude Scott's complaint is suspended while the Commission considers the request for mediation.

3. This order is effective when issued.


