ORDER RECOGNIZING NAME CHANGE AND APPROVING TARIFF SHEETS

Issue Date: February 10, 2020 Effective Date: February 29, 2020 On January 23, 2020, Veolia Energy Kansas City, Inc., filed a notice informing the Commission it is changing its name to Vicinity Energy Kansas City, Inc. Veolia Energy also submitted Adoption Notice Tariff Sheets, whereby Vicinity Energy Kansas City, Inc., will adopt the tariffs of Veolia Energy Kansas City, Inc., effective February 29, 2020.¹ In addition, Veolia Energy filed an application for waiver of the 60-day notice requirement under Commission Rule 20 CSR 4240-4.017.

The Staff of the Missouri Public Service Commission on February 7, 2020, filed a recommendation advising the Commission to recognize the name change and approve the tariff sheets. The Commission will do so.

In addition, the Commission will grant Veolia Energy's request for waiver of the 60day notice requirement under 20 CSR 4240-4.017. The Commission finds good cause exists to waive the 60-day notice requirement based on Veolia Energy's verified declaration that it had no communication with the Office of the Commission regarding substantive issues in the application within 150 days before Veolia Energy filed its application. In addition, the Commission will approve the proposed substitute tariff sheets

with fewer than 30 days' notice. The Commission finds good cause exists in this instance because of the necessity of promptly clarifying Veolia Energy's identity.

City, Inc., to Vicinity Energy Kansas City, Inc.

2. The proposed substitute tariff sheets submitted under Tariff Nos. YH-2020-
