ORDER CANCELING FEBRUARY PREHEARING CONFERENCE

The Commission has scheduled a prehearing conference for February 11, 2020, on Unice Harris' complaint against Kansas City Power & Light Company.¹ On the morning of February 11, 2020, Ms. Harris requested that the prehearing conference be postponed to allow an attorney to enter an appearance.

The Commission finds Ms. Harris' request reasonable and will grant it. The Commission will cancel the February 11, 2020, prehearing conference.

In order to allow Ms. Harris' specified attorney to enter his appearance, the Commission will wait until the earlier of an entry of appearance by a licensed attorney on behalf of Ms. Harris, or February 25 to reschedule the prehearing conference.
