On February 12, 2020, Allegiant Networks, LLC (Allegiant Networks) filed an Application for registration to provide interconnected voice over internet protocol service. Allegiant Networks' application was not complete in that it lacks a copy of its Certificate of Registration from the Missouri Secretary of State's Office, as required by 20 CSR 4240-28.011. The Commission will not take action on this request until this deficiency is corrected. The Commission will leave the file open until March 9, 2020, to allow Allegiant Networks to correct the deficiency. If no response is filed by that time, the Commission will reject the request and close the file.
