Per the *Order Setting Procedural Schedule* issued by the Commission on August 7, 2024, the evidentiary hearing in this matter is currently scheduled for February 27 through March 12, 2025.

- 2. The start of the evidentiary hearing in this matter is suspended until March 3, 2025.
- 3. The parties shall file a stipulation and agreement and a proposed revised hearing schedule, or a status report, no later than February 28, 2025.
