**ORDER WITHDRAWING ORDER DIRECTING STAFF TO FILE  
CONFIDENTIAL VERSION OF TESTIMONY**

On June 10, 2022, the Commission issued an order that directed Staff to file a highly confidential version of the Rebuttal Testimony of Brooke Mastrogiannis, which includes a public version of Schedule BMM-r3, which is the testimony of another witness from another case. The Commission was concerned that pages 53 through 56 of that schedule indicate they are deemed highly confidential in their entirety and the information contained in those pages was not available for the Commission's review. The Commission has since come to understand that Ms. Mastrogiannis does not cite to, or rely on, the highly confidential and voluminous portion of the other witness' testimony. With that understanding, the earlier order is unnecessary and will be withdrawn.

**THE COMMISSION ORDERS THAT:**

1. The Commission's Order Directing Staff to File Confidential Version of Testimony issued on June 10, 2022 is withdrawn.

2. This order shall be effective when issued.
