**ORDER GRANTING MOTION TO AMEND PROCEDURAL SCHEDULE**

Effective Date: February 13, 2020

On January 31, 2020, Union Electric Company d/b/a Ameren Missouri (Ameren Missouri), on behalf of all the parties, filed a motion requesting that certain procedural dates be amended. Ameren Missouri relates that the parties have been engaged in settlement discussions and have agreed in principle to a settlement of all revenue requirement issues except two issues raised by the Office of the Public Counsel and the issues raised by the Sierra Club. Additionally, the parties are continuing to discuss the settlement of the rate design issues. In anticipation of filing a formal settlement agreement on at least some of the issues, the parties request that the required surrebuttal testimony filing be amended and that the date for filing the issues list be amended.

The Commission has considered the request and determines that it should be granted. The Commission will alter the procedural schedule as set out below.

**THE COMMISSION ORDERS THAT:**

1. The Motion to Modify Procedural Schedule filed on February 11, 2020, by Union Electric Company d/b/a Ameren Missouri is granted.
2. The procedural schedule is amended as follows:
  - a. Surrebuttal Testimony shall be filed no later than February 14, 2020, on the affiliate transaction issue raised by the Office of the Public Counsel's

witness, Robert Schallenberg; the Fuel Adjustment Clause sharing percentage issue raised by Office of the Public Counsel's witness, Lena Mantle; and the issues raised by the Sierra Club.

- b. Surrebuttal Testimony shall be filed no later than February 18, 2020, on all rate design issues.
  - c. Surrebuttal Testimony workpapers from all parties shall be provided to the other parties one business day after the surrebuttal testimony for that issue is filed.
  - d. The List of Issues shall be filed no later than February 20, 2020.
3. This order is effective when issued.


