On February 12, 2020, Goldie Bockstruck, attorney of record for Spire Missouri, Inc., (Spire) telephoned Judge Paul Graham. She advised Judge Graham she had consulted with other counsel before contacting him. She inquired of the judge whether physical evidence earlier lodged by Spire with the Commission Data Center was securely housed indoors or whether it was “out-of-doors” on a “dock” where it might be accessible to unauthorized persons.
