ORDER ESTABLISHING ENDING ACA BALANCE

Issue Date: February 13, 2020 Effective Date: March 14, 2020

The Commission opened this case to receive the 2017-2018 Purchased Gas Adjustment (PGA) and Actual Cost Adjustment (ACA) filings of Liberty Utilities (Midstates Natural Gas) Corp. d/b/a Liberty Utilities (Liberty). The Staff of the Commission filed a recommendation regarding that ACA filing on December 10, 2019. Staff's recommendation and memorandum indicated Staff had completed an audit of billed revenues and actual gas costs, for the period September 1, 2017 through August 31, 2018, that were included in Liberty's computation of its ACA balances.

Staff's recommendation and memorandum sets out the ending balance contained in Liberty's ACA filing, but does not recommended any monetary adjustments to that ending balance. Staff also offered some non-monetary recommendations regarding Liberty's policies and practices. Liberty responded to Staff's recommendations on January 23, 2020, addressing Staff's non-monetary recommendations. On February 3, 2020, Staff replied to Liberty's response, advising the Commission that there are no issues to be resolved and advising the Commission to establish the ending ACA balances recommended by Staff.

After reviewing Staff's recommendations and Liberty's responses, the Commission concludes that Staff's ending ACA balances should be accepted as a resolution of Liberty's 2017-2018 ACA audit.

THE COMMISSION ORDERS THAT:

 The ending (over)/under recovery balance for Liberty Utilities (Midstates Natural Gas) Corp. d/b/a Liberty Utilities' 2017-2018 Actual Cost Adjustment are established as provided in the following table:
