On September 15, 2021, the Empire District Electric Company d/b/a Liberty filed tariff sheets and an application seeking the Commission's approval to establish a Demand Side Investment Mechanism pursuant to the Missouri Energy Efficiency Investment Act. On September 20, 2021, Midwest Energy Consumers Group filed an application to intervene. Commission rule 20 CSR 4240-2.080(13) provides that parties shall be allowed ten days from the date of filing in which to respond to any pleading unless otherwise ordered by the Commission. Ten days have elapsed, and no party has objected to the application to intervene. The application satisfies the requirements of Commission Rule 20 CSR 4240-2.075 and intervention will be granted.
