Good evening, all. Please see below and attached for Liberty's proposal to address Staff's and OPC's concerns and move this case forward. We look forward to talking the parties through this proposal and answering any questions you may have on our call at 2:00 on Tuesday.

- All parties to current docket stipulate and agree as follows:
  - Liberty withdraws the tariff sheets filed 11/6/24 and substituted 2/3/25;
  - Staff and OPC withdraw the motions to dismiss;
  - In the current docket, Liberty files "new" revised tariff sheets with a current issue date and 30-day requested effective date, along with corrected direct testimony and MFRs only as needed to address base rate tariff sheets issue;
  - The parties continue to agree on the test year and update period (remaining the same);
  - The Commission will issue an order suspending the "new" revised tariff sheets and send notice to the County Commissions and Missouri Legislators;
  - The parties agree to a revised proposed procedural schedule (attached); and
  - Agreement that data requests on Liberty's direct filing do not need to be re-issued.
