December 13, 2024, Evergy Missouri Metro ("EMM") and Evergy Missouri West ("EMW") (collectively "Evergy"), filed an application for a Depreciation Authority Order ("DAO"). Staff reviewed Evergy's application and submitted its recommendations on February 11, 2025 for the approval of requests b), c), and d) as requested in the application and, in lieu of approval of request a) wherein Evergy requested the Commission authorize EMM and EMW to utilize the depreciation rates in Exhibit A of its application, Staff prepared and submitted updated depreciation rate schedules in Attachment A to Staff's recommendation memorandum. Staff has since been made aware of some errors to its depreciation rate schedules and has attached the corrected schedules herein as Corrected Attachment A. The corrected depreciation rate schedules submitted herewith are intended to replace the depreciation rate schedules attached to Staff's original recommendation memorandum. However, this supplemental memorandum is merely intended to supplement, rather than replace, the original memorandum. Additionally, Staff had previously included account 31209 in its depreciation rate schedules. Staff has removed this account from the depreciation rate schedules, as it is an Industrial Steam account which will need to be addressed in a different filing.
