On January 31, 2025, The Empire District Electric Company filed an application and tariff sheets seeking approval for its Missouri Energy Efficiency Investment Act (MEEIA) Cycle 2. On February 18, 2025, Renew Missouri Advocates d/b/a Renew Missouri filed an application to intervene. Ten days have elapsed, and no party has objected to the application to intervene.¹ The application satisfies all requirements of Commission Rule 20 CSR 4240-2.075 and intervention will be granted.
