RESPONSE TO EVERGY’S RES COMPLIANCE REPORTS  
AND RES COMPLIANCE PLANS**

On July 28, 2022, the Office of the Public Counsel (OPC) filed its response to 2021 RES compliance reports and 2022 RES compliance plans filed by Evergy West, Inc. d/b/a Evergy Missouri West (Evergy West) and Evergy Metro, Inc., d/b/a Evergy Missouri Metro (Evergy Metro) (together – Evergy). In its response, OPC requests the Commission to direct Evergy to recalculate the retail rate impact reported in its filings and to file revised reports and plans to correct those errors and omissions. Greater than ten days have passed and Evergy has not replied to OPC’s response to its reports and plans.

The Commission will direct Evergy to respond to OPC's response to its 2021 RES compliance reports and 2022 RES compliance plans no later than August 24, 2022.

**THE COMMISSION ORDERS THAT:**

1. Evergy shall reply to *Public Counsel's Response to Evergy's RES Compliance Reports and RES Compliance Plans* no later than August 24, 2022.
2. This order shall be effective when issued.
