## ORDER OF RULEMAKING

By the authority vested in the Public Service Commission under section 386.250, RSMo 2016, the commission rescinds a rule as follows:

**20 CSR 4240-3.600** Filing Requirements for Water Utility Applications for Certificates of Convenience and Necessity **is rescinded**.

A notice of proposed rulemaking containing the proposed rescission was published in the *Missouri Register* on Nov. 15, 2024 (49 MoReg 1716-1717). No changes have been made to the proposed rescission, so it is not reprinted here. This proposed rescission becomes effective thirty (30) days after publication in the *Code of State Regulations*.
