Direct Testimony of Jared Giacone

NATURAL GAS INVENTORY 1 2 Q. What is natural gas inventory? 3 A. Natural gas inventory is an investment by the Ameren Missouri gas utility for 4 natural gas that is stored for use by its customers. The investment is included in rate base which 5 allows Ameren Missouri the opportunity to earn a return on its investment. Q. 6 Does the level of natural gas inventory fluctuate over time? 7 A. Yes, there is typically a build-up of inventory going into the colder winter 8 months and a draw down of inventory as the weather warms up going into the summer months. 9 Q. What level of natural gas inventory do you recommend to include in the cost 10 of service? 11 A. I analyzed the natural gas inventory levels and unit pricing over multiple years. 12 I recommend a 13-month average of natural gas inventory for both quantity and price for the 13 13-month period ending June 2024 to correspond with Staff's June 30, 2024, update period. 14 The 13-month average of quantity and price results in a normalized value for natural gas 15 inventory to include in rate base. Ameren also used a 13-month average of natural gas inventory 16 in its direct case for the test year ending March 31, 2024. 17 Q. Does this conclude your direct testimony? 18 A. Yes, it does.
