**ORDER DIRECTING AN EXPEDITED STAFF TARIFF
RECOMMENDATION AND SHORTENING THE TIME FOR OBJECTIONS
OR COMMENTS**

On February 28, 2025, The Empire District Electric Company d/b/a Liberty filed a proposed tariff revision, Tracking No. JE-2025-0129, which bears an effective date of April 1, 2025. On March 3, 2025, Liberty extended the tariff's effective date to April 14, 2025.

Liberty's tariff revision is an additional true-up outside of its required annual true-up. Liberty states that this additional true-up is necessary due to variance in actual electric usage resulting in an under collection of revenue to pay the January 1, 2025, securitized utility tariff bond payment. Liberty used funds from its capital account to make the bond payment.

The Commission will direct its Staff (Staff) to file a recommendation about the tariff sheet on an expedited basis, and will set a time for filing any other objections or comments.

THE COMMISSION ORDERS THAT:

1. Staff must file a recommendation about Liberty's tariff sheet no later than March 11, 2025.

2. Any comments or objections about Liberty's tariff sheet must be filed no later than March 14, 2025.

3. This order is effective when issued.
