White River Valley Cooperative, Inc. filed an application on February 19, 2025 pursuant to RSMo 386.800.3 and 20 CSR 4240-20.045, for an Order Approving Designated Service Boundaries. On February 19, 2025 White River Valley Electric Cooperative also filed a Motion for Protective Order citing 20 CSR 4240-2.135(2). No party has objected to the filing of the Motion. The rule cited by the Applicant requires the information requested in the Motion should be filed in EFIS. The Cooperative can file both a public description with no confidential information, along with filing a confidential version of the information in EFIS. If the Cooperative seeks further protection, a motion for protective order would be appropriate after the confidential filing.

1. The Commission will deny the Motion for Protective Order.
2. This order shall be effective when issued.
