**ORDER GRANTING STAFF’S MOTION FOR AN EXTENSION**

The Commission held a procedural conference on February 6, 2025, to discuss The Empire District Electric Company d/b/a Liberty’s plan to resolve this case by agreement of the parties. On February 10, 2025, the Commission directed the parties to file any stipulation and agreement or request for additional time by March 3, 2025.

On March 3, 2025, Liberty filed its *Unopposed Request for Additional Time* asking to have until March 10, 2025, to file a settlement agreement. In support of its motion, Liberty states that the parties have reached a settlement in principle and need additional time to finalize that agreement.

The Commission will grant the motion for an extension.

**THE COMMISSION ORDERS THAT:**

1. Liberty’s motion for an extension is granted. The parties shall file any stipulation and agreement no later than March 10, 2025.
