**MOTION FOR EXTENSION**

**COMES NOW** the Staff of the Missouri Public Service Commission (“Staff”), by and through counsel, and for its *Motion for Extension*, states as follows:

1. On February 18, 2025, the Commission held a prehearing conference to discuss a procedural schedule and to set a hearing date.
2. Also on February 18, 2025, the Commission issued its *Order Directing Filing*, ordering Staff to file a joint proposed procedural schedule no later than March 4, 2025.
3. Staff has been in communication with Complainant and Respondent (the “Parties”) regarding the content of and dates for a proposed procedural schedule.
4. Staff is still communicating with the Parties to confirm agreement regarding the proposed procedural schedule and respectfully requests that the Commission grant an extension to file the joint proposed procedural schedule through March 18, 2025.
