## ORDER EXTENDING TIME

On February 18, 2025,<sup>1</sup> the Commission held a prehearing conference to discuss a procedural schedule and to set a hearing date. That same day, the Commission directed the Staff of the Commission (Staff) to file a joint proposed procedural schedule for the parties by March 4.

On March 4, Staff filed a *Motion for Extension* stating that the parties are still communicating to confirm agreement regarding a proposed procedural schedule. The *Motion* sought an extension of time for the joint proposed procedural schedule to March 18. The Commission finds the request reasonable and will grant it.

#### THE COMMISSION ORDERS THAT:

- 1. The *Motion* is granted. Staff shall file a proposed procedural schedule no later than March 18, 2025.
