# ORDER DENYING MOTION TO MODIFY SCHEDULE

Issue Date: June 8, 2017

Effective Date: June 8, 2017

On April 19, 2017, the Commission issued a Report and Order that rejected a tariff previously filed by Union Electric Company d/b/a Ameren Missouri ("Ameren Missouri") and directed Ameren Missouri to file a revised tariff in compliance with the order regarding the resale of electricity for EV charging stations. On May 18, 2017, the Company filed the tariff with an effective date of June 17, 2017. In response to information in a Staff recommendation, the Commission rejected that tariff on June 7, 2017 and directed Ameren Missouri to submit a new tariff with specific revisions no later than June 9, 2017. On June 8, 2017, Ameren Missouri filed a Motion to Modify Schedule and for Expedited Consideration ("Motion").

In its Motion, Ameren Missouri requests that the Commission delay the filing of the revised tariff until after the Commission rules on Ameren Missouri's pending Application for Rehearing in this case. Ameren Missouri argues that since the tariff changes ordered by the Commission directly relate to the issue in the Application for Rehearing, it would be inappropriate to change the tariff until the Commission has determined whether Ameren Missouri's position has merit.

The Commission's usual practice is to resolve compliance tariff matters prior to ruling on an application for rehearing, since the Commission may lose the authority to issue orders in a case after a notice of appeal has been filed. The Commission finds that Ameren Missouri would not be prejudiced by filing the compliance tariff first, as that tariff could be amended later if the Commission were to grant Ameren Missouri's Application for Rehearing. The Commission concludes that it is more appropriate to resolve the compliance tariff before ruling on the Application for Rehearing, so the Commission will deny the Motion.

# THE COMMISSION ORDERS THAT:

1. Union Electric Company d/b/a Ameren Missouri's Motion to Modify Schedule and for Expedited Consideration filed on June 8, 2017, is denied.

2. This order shall be effective when issued.
