### STAFF'S COMPLIANCE TARIFF RECOMMENDATION

**COMES NOW** the Staff of the Missouri Public Service Commission ("Staff"), through counsel, and states as follows:

- 1. On August 26, 2024, Confluence Rivers Utility Operating Company, Inc. ("Confluence") filed an Application and Motion for Waiver ("Application") with the Missouri Public Service Commission ("Commission"), asking the Commission to: authorize Confluence to acquire Gascony Water Company, Inc. ("Gascony"); transfer Gascony's Certificate of Convenience and Necessity ("CCN") to Confluence, or grant Confluence a new CCN; and waive the 60-day notice requirement.
- 2. On November 26, 2024, Staff filed the *Staff's Report and Recommendation*, recommending the Commission's approval of the abovementioned requests, with conditions. One of these conditions requires Confluence submit an adoption notice prior to closing on the assets, to adopt the existing Gascony tariffs.
- 3. On December 19, 2024, the Commission issued an order approving the acquisition, canceling Gascony's CCN and granting Confluence a CCN, waiving the 60-day notice requirement, and adopting Staff's abovementioned condition.
- 4. On February 22, 2025, Confluence filed the adoption notice as well as the following tariff sheet:

P.S.C. MO. No. 32

First Revised Sheet No. 6 Canceling Original Sheet No. 6.

5. Staff reviewed the above tariff sheet and finds that the only revision to the

tariff adopted from Gascony by Confluence is the conversion from quarterly rates to

monthly rates.

6. Thus, Staff finds the tariff sheet above to be compliant with the

Commission's Order Approving Acquisition, Canceling Certificates and Granting a

Certificate of Convenience and Necessity.

7. Therefore, Staff recommends approval of the above tariff sheet.

WHEREFORE, Staff prays that the Commission will accept Staff's Compliance

Tariff and Recommendation as compliant with the Commission's Orders.
