On February 13, 2025, Ritter Communications Holdings, LLC d/b/a Ritter Communications, pursuant to Section 67.2679.7, RSMo 2016, filed a Notice of Change Application seeking to expand video service to the following political subdivisions:

On January 4, 2021, the Commission authorized Ritter Communications to provide video service in the following political subdivisions:

The Commission has reviewed the application filed by Ritter Communications and finds that it and the attached affidavit comply with the filing requirements set forth in Section 67.2679.7, RSMo 2016.

THE COMMISSION ORDERS THAT:

1. Ritter Communications is granted authority to provide video service in the franchise area of each political subdivisions set forth in the application and restated above.

2. Ritter Communications is granted authority to construct a video service network along, across, or on public rights-of-way for the delivery of video service to the extent the video service provider or an affiliate did not otherwise possess a valid authorization to occupy the public rights-of-way.

3. This order shall become effective when issued, after which this file may be closed.
