On September 30, 2016¹, KCP&L Greater Missouri Operations Company ("GMO") submitted a letter and tariff designed to adjust its renewable energy standard rate adjustment mechanism pursuant to Commission Rule 4 CSR 240-20.100. The submitted tariff bore an effective date of December 1, 2016. The Commission issued notice of the request and set an intervention deadline. But the Commission received no intervention requests.

On November 8, after discussions with the Staff of the Commission, GMO withdrew its previous tariff and submitted the currently pending tariff.² GMO also filed a Motion for Expedited Consideration and Approval of Tariff Sheet on Less Than Thirty Days' Notice. On November 9, the Staff of the Commission ("Staff") filed its Staff Recommendation to Approve Revised Tariff Sheets and to Grant Motion for Expedited Treatment.

Before the Commission rules on these pleadings, the Commission will allow other parties to respond.
