ORDER DIRECTING LIBERTY TO FILE A TARIFF EXTENSION

On February 28, 2025, The Empire District Electric Company d/b/a Liberty filed a proposed tariff revision, Tracking No. JE-2025-0129, which bears an effective date of April 1, 2025. Liberty later attempted to extend the effective date of the tariff to April 14, 2025. Commission Rule 20 CSR 4240-2.065(6) requires that Liberty file a letter extending the tariff's effective date in the official case file (EFIS). Accordingly, the Commission will direct Liberty to file a letter extending the effective date of its proposed tariff revision.

THE COMMISSION ORDERS THAT:

1. Liberty shall file a letter extending the effective date of its proposed tariff revision, Tracking No. JE-2025-0129.
2. This order is effective when issued.
