ORDER SUSPENDING PROCEDURAL SCHEDULE

On June 12, 2018, Union Electric Company d/b/a Ameren Missouri, the Staff of the Commission, Missouri Department of Economic Development-Division of Energy, Wal-Mart Stores, Inc., Missouri Industrial Energy Consumers, Wind on the Wires, Natural Resources Defense Council, Sierra Club, Renew Missouri Advocates d/b/a Renew Missouri, and the Office of the Public Counsel filed a Second Non-Unanimous Stipulation and Agreement (“Agreement”) stating that the Agreement resolves all issues in this proceeding. Those signatories also concurrently filed a Joint Motion to Suspend Procedural Schedule.

Kansas City Power & Light Company and KCP&L Greater Missouri Operations Company are not signatories to the Agreement, but the signatory parties represent that those two companies have indicated they do not oppose the Agreement or the motion to suspend the procedural schedule. Given the apparent agreement of the parties, there is no need to maintain the procedural schedule. The procedural schedule will be suspended indefinitely.

THE COMMISSION ORDERS THAT:

1. The Joint Motion to Suspend Procedural Schedule filed on June 12, 2018, is granted. The procedural schedule for this case is suspended until further order of the Commission.
2. This order shall be effective when issued.
