**ORDER SCHEDULING AN ON-THE-RECORD PROCEEDING
REGARDING A STIPULATION AND AGREEMENT**

On June 12, 2018, Union Electric Company d/b/a Ameren Missouri, the Staff of the Commission, Missouri Department of Economic Development-Division of Energy, Wal-Mart Stores, Inc., Missouri Industrial Energy Consumers, Wind on the Wires, Natural Resources Defense Council, Sierra Club, Renew Missouri Advocates d/b/a Renew Missouri, and the Office of the Public Counsel filed a Second Non-Unanimous Stipulation and Agreement (“Agreement”) stating that the Agreement resolves all issues in this proceeding. On June 13, 2018, the Commission issued an order suspending the procedural schedule. The Commission would like to question the parties about the Agreement and will schedule an on-the-record proceeding for that purpose.

THE COMMISSION ORDERS THAT:

1. An on-the-record proceeding for the purpose of questioning the parties about the proposed stipulation and agreement is scheduled for Tuesday June 26, 2018 beginning at 10:00 a.m., at the Commission’s office at the Governor Office Building, Room 310, 200 Madison Street, Jefferson City, Missouri.
