The Commission will direct its Staff to consult with the other parties and submit a proposed procedural schedule including an evidentiary hearing. The Commission's current hearing schedule is very full. The parties are free to propose other dates for an evidentiary hearing, but the first two weeks of July 2025 appear to be the only free weeks with no other evidentiary hearings scheduled.

THE COMMISSION ORDERS THAT:

1. The Commission's Staff shall file a proposed procedural schedule on behalf of the parties no later than March 20, 2025.
2. This order shall be effective when issued.
