**ORDER GRANTING APPLICATION TO INTERVENE AND
DIRECTING RESPONSES TO STAFF RECOMMENDATION**

On January 3, 2020, Union Electric Company, d/b/a Ameren Missouri filed an application seeking variance from certain provisions of Commission Rule 20 CSR 4240-20.065, concerning net metering applications. On January 13, 2020, Ameren Missouri filed an amended request for variance with a request for waiver of the 60-day notice requirement under 20 CSR 4240-4.017.

On February 3, 2020, Renew Missouri Advocates d/b/a Renew Missouri filed an application to intervene. Renew Missouri's application contends its interests are different from the general public and may be adversely affected by a final order in this case. Renew Missouri's application also contends allowing Renew Missouri to intervene will serve the public interest by "assisting the Commission's record for decision." More than 10 days have passed since Renew Missouri applied to intervene; no party has objected to Renew Missouri's application.

The Commission will grant Renew Missouri's application to intervene based on a determination that intervention will serve the public interest.¹

¹ Bases for granting intervention include a finding intervention will serve the public interest. 20 CSR 4240-2.075(3).

In addition, the Commission will establish deadlines for any response to Ameren Missouri's application and amended request, filed on January 3 and 13, 2020, and any response to the recommendation of Commission Staff, filed on February 13, 2020.

THE COMMISSION ORDERS THAT:

1. Renew Missouri Advocates d/b/a Renew Missouri's application to intervene is granted.
2. Any response to Union Electric Company d/b/a Ameren Missouri's request for variance, filed on January 3, 2020, and amended request, filed on January 13, 2020, shall be filed no later than February 24, 2020.
3. Any response to *Staff Recommendation*, filed on February 13, 2020, shall be filed no later than February 24, 2020.
4. This order shall be effective when issued.
